#### 1. FAREWELL

## 2. WELCOME

We warmly welcome new members who have been enrolled in 'CENTRAL DEWA' during the period under review. We also cordially receive our old members who have come back either on transfer or on promotion from other centres/cities.

## 3. ACTIVITIES

- (i) During the period of two years, 34 new members have sought the membership of our Association. Due to Corona pandemic (since March, 2020), less members have taken the DEWA Membership during the period.
