

**SECRETARY'S REPORT AND AUDITED STATEMENT OF ACCOITS OF 'CENTRAL DEWA' FOR THE PERIOD FROM 01-10-2021 TO 30-09-2022 PRESENTED AT THE 'ANNUAL GENERAL BODY MEETING' ON 2<sup>nd</sup> OCTOBER, 2022 (Sunday) AT Shiv Mandir , VP House , Rafi Marg, New Delhi-110003 .**

**Dear Members,**

On behalf of the 'Executive Committee of Central DEWA', I have great pleasure in welcoming all of you to the 'Annual General Body Meeting' (AGM) of the Association and place before you the report on the various activities of 'CENTRAL DEWA' since the last AGM held on 2<sup>nd</sup> October, 2021.

**1. FAREWELL**

We heartily bid good bye and best wishes to those members who have gone on promotion or on better prospects elsewhere in India or abroad.

**2. WELCOME**

We warmly welcome new members who have been enrolled in 'CENTRAL DEWA' during the period under review. We also cordially receive our old members who have come back either on transfer or on promotion from other centres/cities.

**3. ACTIVITIES**

- (i) During the period of one year , 14 new members have sought the membership of our Association. Due to Corona restrictions declared between December, 2021 & April , 2022 , less members have taken the DEWA Membership during the period.
- (ii) During the period of two years , nine (09) Executive Committee Meetings (including two Managing Committee meetings) were held in which various issues/matters were taken up for discussions and necessary decisions were taken thereon.
- (iii) Though the declaration & arrangements to organise the '*Family Get-together of the community on 25-12-2021*' were made , yet it was cancelled due to corona restriction announced by Delhi Government on 22<sup>nd</sup> December, 2021.
- (iv) DEWA could not organise the 'Yuvak -Yuvati Parichay Sammelan' during this year but it (DEWA) has restarted 'Free Matrimonial Service' (to our community people) on the First Sunday of each month at Shiv Mandir ( near VP House), Rafi Marg, New Delhi from March, 2022 onwards.
- (v) DEWA has carried out a great project (Installation of Sant Gadge Murti at Shiv Mandir) with the active participations/cooperations/donations from specially 'DEWA Executive Committee Members' and 'some other DEWA Members also'. A Team of Seven Members of Executive Committee (EC) visited Akbarpur (near Alwar), Rajasthan on 13<sup>th</sup> November, 2021 and placed the order on "Lakshmi Murti Bhandar" for carving/preparing the "Murti of Sant Gadge Maharaj" (on Marble Stone) and thereafter, it was brought to Delhi on 18<sup>th</sup> December, 2021 to Shiv Mandir (behind VP House), Rafi Marg, New Delhi . Before installation of 'Sant Gadge Murti' , various civil & allied works '*i.e. construction of Chabutara , fittings of Tiles on Chabutara including back wall and Shed (metro sheet) on the Chabutara etc*' were got carried out before installing the Sant Gadge Murti at Shiv Mandir Prangan.

The 'Sant Gadge Murti' was put on on 22<sup>nd</sup> February, 2022 on the said constructed Chabutara at Shiv Mandir (with the help local youngsters of our community) and thereafter , a Grand Function for inauguration of 'Sant Gadge Murti' including 'Gadge Jayanti' was organised by DEWA on 23<sup>rd</sup> February, 2022 (on Sant Gadge Jayanti). The 'Sant Gadge Murti' was inaugurated by Shri Kamal Kishore Commando, Ex PM and Sh. Rajesh Kumar Diwakar , Ex MP.

I want to put on record that total expenditure of Rs.1,56,660/- has been incurred on Sant Gadge Murti , Civil & allied works , Inaugural Function (including Gadge Jayanti ) and out of it , an amount of Rs.

1.25.761/- has been collected as donation/help from DEWA EC Members & some other DEWA members within a span of four (04) months only (from November, 2021 to February, 2022), which we never expected the same. I would like to extend special thanks to Prof. Chhotey Lal Kanojia, Patron (donating ₹ 21, 000/-) including three Patrons of DEWA for donating Rs. 5100/ each (Sh S. Lal, Sh. Madan Lal (Hngr) & Sh. Manohar Lal Kashyap), Five Members of 'DEWA Executive Committee' for donating Rs. 5,000/ each (Shri Ram Pal Singh (plus Tiles of Rs, 3000/-), Sh. Jugal Kishore Kanojia, Sh Madan Lal (Ggm), Shr Lekha Ram Diwakar, Sh Ramesh Kumar Kanojia) & an other Member for donating ₹ 5,000/- (Sh Rajeev Kanojia, Janakpuri). I also extend great thanks to remaining all Members of the DEWA Executive Committee for their generous donations and support. I declare with open heart that without their unconditional active support/cooperation from all DEWA Executive Committee Members, the said project (installation of Sant Gadge Murti) would have never been implemented. I want to extend special thanks to Sh Kishan Lal Chauhan, Cultr. Secretary for his continuous support and hard work towards said Project. On behalf of 'DEWA Executive Committee', I extend heartily thanks to the Office bearers of DPDMS for allocating site at Shiv Mandir Prangan for installation of 'Sant Gadge Murti' (specially to Shri Jugal Kishore Kanojia ji and Prof. Chhotey Lal Kanojia ji). I also thanks to Shri Amarjit ji and Shri Ravi Kumar ji and others (office bearers of Shiv Mandir Prabandhan Samiti) for great help in managing to carry out the civil & allied works for installation of Sant Gadge Murti.

(vi) On the occasion of 'Dr. BR Ambedkar Jayanti' on 14th April, 2022, DEWA (jointly with 'DPDMS' and 'ABDM (Delhi Unit)' has participated in the Jayanti (second time with the help of Sh. Kishan Chauhan, Cultr. Secretary-DEWA) by arranging a Stall at Sansad Marg, New Delhi.

(vii) DEWA has participated in the Meeting of 40 nos of different 'Bahujan Sangathans/Organisations' organised by PAGAAM on 18<sup>th</sup> June, 2022 at Lodhi Road (Hall near Sai Mandir), New Delhi. The subject was (i) What are the main reasons for atrocities on Bahujans (OBCs, SCs & STs) being done by non-Bahujans and (ii) What are the remedies being suggested for the same (atrocities)?

(viii) There is no denying that our 'Managing Committee' is getting full co-operation and support from the community people and therefore, it is doing its duty diligently and honestly without any favour. Despite our best welfare services to the community, we are fully receptive to the valid suggestion from the community persons. As regards expenditure, we spend DEWA's fund very thriftily and are always wary of austerity in expenditure of the Association, which is evident from 'Statement of Accounts' submitted before AGM.
